## MEMORANDUM OF UNDERSTANDING

# Association Internationale de Recherche en Management Public (AIRMAP) Nice, France

#### AND

### Korea Institute of Public Administration (KIPA) Seoul, Republic of Korea

The Association Internationale de Recherche en Management Public (AIRMAP), represented by AIRMAP President Dr. Pierre-Charles Pupion, and the Korea Institute of Public Administration (KIPA), represented by KIPA President Dr. Yoon-soo Jung, (hereinafter referred to as "the Parties") wish to develop the following points regarding the Parties' possibilities for cooperation in the field of public administration:

#### Clause 1

The Parties hereby express their common intention of establishing a long-term cooperation in the realms of performing scientific research in order to jointly pursue educational and academic activities, as well as mutually utilize the achieved results.

Additionally, this agreement is intended to determine the nature and the guidelines for mutually beneficial cooperation.

#### Clause 2

Cooperation under this Agreement shall take the following forms:

(a) Sharing and exchange of research staffs and resources. The timing, purposes, terms and conditions of such exchanges will be jointly decided

upon by the Parties;

- (b) Facilitating joint research projects through civil servants in both nations and researchers of the Parties on themes or topics jointly decided, copublishing the results thereof. Civil servants and researchers participating or involved in joint research projects shall respect and comply with the laws and regulations of the host country where the joint research projects are being carried out;
- (c) Organizing joint international seminars, conferences and forums in either of the two countries. The theme/topic, venue and participants of the international conference will be jointly decided upon by the Parties;
- (d) Providing mutual opportunities for publishing in each other's academic journals; ensuring mutual access to each other's academic publications and international research outputs in accordance with the laws of the Parties.

#### Clause 3

This Agreement does not establish financial obligations for the Parties. Specific forms of cooperation are implemented on the basis of independent agreements concluded in accordance with the Parties' respective legislation.

#### Clause 4

This Agreement is not intended to create any obligations under international law. In case any controversy and disagreement emerges while implementing the present Agreement, it will be settled by negotiations.

#### Clause 5

This Agreement will come into effect on the date of its signature by both Parties. It will remain in effect for a period of three (3) years and thereafter will be *automatically renewed* for successive periods of three (3) years, unless either Party notifies the other in writing of its intention to terminate this Agreement at least three (3) months prior to the termination date of this Agreement.

#### Clause 6

This Agreement may be revised or modified by mutual consent of the Parties.

#### Clause 7

Both sides are responsible for seeking potential donors and supporters in order to organize joint activities.

#### Clause 8

The Parties consider this Agreement as a framework agreement. All activities carried out under the terms of this Agreement shall be separately negotiated and approved by both institutions, giving consideration to the availability of resources and the individual capabilities of each institution.
