#### **Proposal Submission Information**

#### **Individual Papers**

A single paper proposal must include 1) Conference Track, 2) Titles and Abstracts (no longer than 500 words) of Individual Paper, and 3) Author's Information (name, affiliation, position, and email address).

#### Panel

To be considered, a fully formed panel proposal must include 1) Conference Track, 2) Panel Title, 3) Participants (One panel moderator, One-Two discussants, and Three-Four presenters), and 4) Titles and Abstracts (no longer than 500 words) of Individual Papers.

The panel moderator serving as a panel organizer needs to add information for each participant's name, affiliation, position, and email address.
